MAJOR PROJECTS

NEWMONT BODDINGTON GOLD—Hotham Farm

J & P Deconstruction completed the removal and disposal of a house located on the above property which contained large amounts of asbestos.

The property also had an area of soil contaminated with asbestos, approximately $85m \times 40m$. The soil was removed to a depth of 100mm and disposed of at an approved landfill facility, leaving the area to an excavator rake bucket finish.

ILUKA RESOURCES ENEABBA

Dismantle, Removal and On Sale of Redundant Plant and Equipment located at Iluka Resources Eneabba Site

J&P Deconstruction spent a period of 5 months at the Eneabba site and were required to Dismantle and Remove from site, via J&P Transport, the following redundant plant and equipment:

- 2 x Thickner Tanks
- 1 x Large EDC Unit
- Transformer
- Spiral Banks
- & Pumps

Once removed from site all items were on sold to other customers.

The balance of redundant Plant and Equipment on site, which could not be on sold, was dismantled and transported to our Scrap Processing Facility in Dardanup for processing.









HMAS STIRLING—GARDEN ISLAND 2009

Location: Garden Island, Rockingham WA

Contract: Dismantle & Remove two mobile cranes

Duration: 3 months

The Project:

- Remove & dispose of two mobile cranes without damage to the existing concrete work on each wharf.
 - This was completed in four stages for each mobile crane.
 - The final stage was completed using two cranes and dual crane lift was conducted.

Location: Boddington, Western Australia

Contract:

- Removal & Disposal of 18 Absorption & Residue Tanks. Each tank approx 15m dia x 15m height
- Deconstruction and relocation of Bridge Section situated between Tank Train 1 and Tank Train 2

Duration: 3 months

The Project was in two parts:

- Processing all eighteen tanks, shipping off site the processed steel for export as well as removal of excess plinths, footings and retaining walls to enable the new gold room and processing plant to be erected.
- Deconstruction, relocation and labelling for reassembly a bridge section situated between Tank Train 1 and Tank Train 2.

- High winds and inclement weather.
- Removal of tanks without damaging the surrounding concrete bund wall or damage to the ring beams and external bund walls.
- Removing the bridge section over existing workshop and offices. Utilising the 500t crane with 42m of luff and fly to carry out final lift.
- Working round other on site construction contractors.

Contract: Dismantle & Removal of 1—65t x 50.8m span, overhead Gantry Crane and 3 external frames in excess of 20m high

Duration: 3 months

- Dismantle and removal of one overhead gantry crane which included disabling the brake system and towing the crane to the external area of the shed to gain access to the bridging units for removal.
- Dismantle and removal of six external uprights and gantry runner beams.
